#### **Inspection Comments**

I met with the staff for a routine kennel inspection. Ms. Elizabeth Barfield from the Mayor's office also was present for the inspection.

The building is structurally sound and in good repair. Twelve dogs were housed in collapsible crates in the back area of the shelter as the shelter is beyond capacity and no runs are available. A violation for structural strength 40-13-13-.04(1)(o) is being issued. We have scheduled a reinspection for 11/22/22 for compliance.

Euthanasia records are up to date and complete. The DEA license and laypersons list are current. The shelter license is current (exp. 2/28/23).

Fire extinguishers are present. Food storage meets standards.

Ms. Pearson, Ms. Barfield, and I met at the end of the inspection to discuss the shelter operations.
